However, subsequently if their names/ firms/companies are removed from blacklisting, they are eligible to participate in the tender and have to submit an affidavit for the same (as per ANNEXURE -III). The contractors who are involved in 6-A cases under Essential Commodities Act or in diversion of stocks are prohibited from participating in the Tenders.
- b) The Registered Lorry Owners Associations are eligible to participate in the tenders. In case of hired vehicles, the tenderer should furnish hire agreement with the owners for a minimum period of one year otherwise they are not eligible to participate in tenders. Trucks involved in 6A cases/diversion cases and/ or other trucks belonging to their owners should not be hired. Vehicle details should be furnished in the Tender form. Tenders found without vehicle details and / or copies of the vehicle RC Books, TAX, latest Form. 24(b) (Registered Abstract) in original, Fitness Certificate along with copy of valid National RTA permits stands automatically disqualified. **Articulated vehicles are not permitted.**

- i) The successful tenderers have to utilize their own and hired vehicles which were declared in tenders for movement of gunnies in addition to engaging other vehicles without fail. The tenderer / bidder should not declare vehicles, which were already shown in the tenders of Stage I/ Stage II/ Paddy/ other Gunny transportation tenders or any other transportation tender of the Corporation, where, the contract was awarded to the tenderer (the agreement should be in currency) or due for award to the tenderer for being declared as L1, for qualifying in current Tender-I, Tender-III, Tender-IIII, (West Bengal to Sector-I, II & III districts) and submit a declaration to that effect through ANNEXURE V (A) & (B). Further, the successful tenderer also should not engage the vehicles declared in Stage-I/ Stage-II/ Paddy/ other TGSCSCL transport contracts.
- j) <u>Tenderers should offer separate vehicles for each tender.</u> In case they are filing more than one tender and if the same lorries are offered for more than one tender, the tender filed in both the districts will be rejected out rightly without any consideration.
- k) Age of lorry offered (Year of Model / Make in the RC Book) should not exceed 15 years i.e the lorries model earlier than **Feb 2010** will not be considered.
- I) Trucks belonging to prohibited or ineligible categories like unfit vehicles, articulated vehicles, vehicles used in other transportation tenders of the Corporation and vehicles used for transportation of fish, poultry and cement, to avoid damages and bad odour, shall not be utilized for transportation of gunny bales. In the event of any lapse on the part of the contractor in this regard, the Corporation shall have absolute right to terminate the agreement at any time during the currency of the agreement and to get the work done for the unexpired period of contract at the risk and cost of the contractor besides forfeiture of the Security Deposit, Bank Guarantee, pending bills, if any, and the contractor will be BLACKLISTED. In this regard, the action of the Corporation is final and binding on the contractors.
- m) The period of contract will ordinarily be in force from date of entering into agreement to 31.03.2026 or till the quantity entrusted by the Corporation from time to time to the contractor during the above period for transport is completed. The contract can be extended by the VC & MD, Telangana State Civil Supplies Corporation Limited, at his sole discretion on the same rates, terms and conditions for a further period as determined by VC & MD in view of public interest. The action of the VC & MD, TGSCSCL in extending the contract period shall be final and binding on the contractor and shall not be called into question.

n) <u>Experience requirement</u>: Minimum total quantity to have transported cumulatively between 2017-18, 2018-19, 2019-20, 2020-21, 2021-22, 2022-23, 2023-24 & 2024-25:

Sector I – One lakh bales Sector iii – 40,000 bales Sector iii – 70,000 bales.

An experience certificate issued by the concerned Government organization must be submitted, specifying the quantity transported, commodity, and transportation period performance along with attestation by CA. (Certificate without any of the specifics will be rejected).

<u>Note:</u> In case of tenderers with previous experience of transport work with TGSCSCL/APSCSCL, the past performance of the transporter will be taken into consideration while deciding the eligibility of the tenderer.

7. NEGOTIATIONS:

- a) In case, the L1 tenderer backs out, the VC & Managing Director, TGSCSCL reserves the right to call the L2 tenderer. The decision of the VC & Managing Director in this regard is final and binding on the tenderers and it cannot be called into question by any tenderer.
- b) There shall not be any negotiations with any Tenderer at any level. However the Corporation reserves the right to negotiate with L1 if required.
- c) Depending on rates received, negotiations will be conducted with the L1 tenderer. Such negotiations will be held as decided and announced during the process of opening of tenders. No separate intimation will be sent to tenderers about negotiations.
- d) The VC & Managing Director, TGSCSCL reserves the right to call all the tenderers for further negotiations, if necessary. The decision of the VC & Managing Director in this regard is final and binding on the tenderers and it cannot be called into question by any tenderer.
- e) The VC & Managing Director, TGSCSCL reserves the right to award the tender in full or in part to one or several parties. The decision of the V.C. & Managing Director is final and binding on the tenderers.
- f) The VC & Managing Director, TGSCSCL reserves the right to reject any or all the tenders without assigning any reasons whatsoever and the decision of the V.C. & Managing Director in this regard is final and binding on the tenderer and cannot be called into question
- g) No Tenderer is entitled to withdraw his offer at any stage during or after the tender process. If he withdraws the offer, his EMD stands forfeited without any notice and he will be blacklisted from participating in future Tenders of the Corporation.
- h) No tenderer shall have the right to insist on negotiations by the Corporation at any time.
- i) Tenderers should quote their negotiated rates in person, only at the time of negotiations.
- j) During negotiations, no tenderer is permitted to quote higher rates i.e. more than the rates quoted in the original financial bid. Any explanation or interpretation either oral or in writing on the quoted rates after commencement/completion of Tender process will not be accepted under any circumstances.

8. EARNEST MONEY DEPOSIT(EMD):

a) Every tender should be accompanied by an Account Payee Demand Draft of EMD as mentioned below, along with technical tender drawn in favour of "Telangana State Civil Supplies Corporation Limited, Hyderabad" from any Nationalized/Scheduled commercial Bank. Separate EMDs should be submitted for each Tender. Tenders without prescribed EMD stands summarily rejected. No adjustment of existing Security Deposit of contractors will be accepted. Tenders enclosing cheques will also stand summarily rejected. Tenderers should scan and upload the EMD Demand Draft along with other documents required for Technical Tender. The Original EMD DD should be furnished along with hard copies to be submitted as per time schedule. In case the EMD is paid through other options available in e-procurement platform, the tenderer has to furnish proof of submission of EMD

- b) Earnest Money Deposit will not carry any interest.
- c) EMD of the successful tenderer stands adjusted towards Security Deposit and they should deposit the balance Security Deposit in the form of D.D. in favour of Telangana State Civil Supplies Corporation Limited, payable at Hyderabad from any Nationalized/ scheduled commercial Bank.
- d) EMD is liable to be forfeited besides blacklisting the tenderer, in case the tenderer backs out after filing the tender or after the acceptance of the offer by the TGSCSCL or fails to enter into agreement or fails to remit the balance Security Deposit within the specified time.
- e) In case of unsuccessful tenderers, this EMD will be returned after the successful tenderer executes the agreement. In case the successful tenderer fails to execute the agreement within three days of offer of contract, the EMD will be forfeited and award of contract will be cancelled besides collecting liquidated damages and **blacklisting**.
- f) The EMD of unsuccessful Tenderers will be returned only to the person on whose name the Tender is filed (or) by REGISTER POST ACK DUE to the postal address given in the Tender Form.

g) SECURITY DEPOSIT:

The Successful Tenderer should submit the demand draft Rs. /(Rupees only) each drawn on any Nationalized/Scheduled commercial Bank towards Security Deposit within three days and enter into agreement. Demand Draft should be drawn in favour of "Telangana State Civil Supplies Corporation Limited, Hyderabad", payable at Hyderabad. EMD of the successful tenderer will be adjusted towards Security Deposit and only balance Security Deposit should be furnished at the time of execution of Agreement.

h) AGREEMENT

Successful tenderer should execute agreement immediately by furnishing the Security Deposit as prescribed within three (3) days from the date of receipt of award of contract. In the event of failure to execute the agreement, the Security Deposit OR EMD as the case may be stands forfeited apart from

cancellation of contract besides blacklisting of the tenderer and Corporation is entitled to collect liquidated damages if any from the tenderer for his failure to comply with the terms and conditions of the Tender.

i) BANK GUARANTEE:

j) FORFEITURE:

The decision of the VC & Managing Director in finalization of the tenders is final and binding on the tenderers.
- b) Transport Contractor shall transport gunnies entrusted by Government from time to time to various destinations as per the movement orders issued by the H.O/ District Manager from time to time. In case of any deviation in movement of gunnies as per movement orders issued by H.O/ District Manager, transport charges will be paid and restricted strictly as per movement instructions issued by H.O / District Manager only. The VC & MD, TGSCSCL has every right to retransport stocks, at the risk and cost of the transport contractor wherever, transport contractor deviates from the issued movement instructions.
- c) In case Transport Contractor is suspended due to violation of terms and conditions of the Agreement under any contract with the Corporation, all other contracts of the said contractor with the Corporation, if any, will also be suspended and all payments to the contractor under all Agreements will be frozen.
- d) In case Transport Contract is terminated due to violation of terms and conditions of the Agreement under any contract with the Corporation, all other contracts of the said contractor with the Corporation, if any, will also be terminated and all payments to the contractor including securities under all Agreements will be forfeited.
- e) Other terms and conditions as embodied in the agreement to be signed by the successful tenderer shall also be applicable in determining the eligibility of the tenderer and be part of contract. Apart from all the conditions of tender Circular instructions issued by VC & Managing Director / Joint Collector & EOED / Dist. Managers from time to time, marked to the Contractor shall also form part and parcel of the contract.

- f) In case of diversion of trucks by Transport contractor FIRST INFORMATION REPORT (FIR) will be filed against the Contractor by name as Accused No. 1, his authorized business representative by name as Accused No. 2. Lorry driver and cleaner by name as accused No.3 and 4 respectively strictly by following the VC & MD, APSCSCL Circular No. 14, dated 23.08.2005.
- g) The Corporation is operating MS/HSD outlets in certain districts. Transport Contractor should make use of the above outlets for drawing fuel and other lubricants for the vehicles being used by him for transportation of Gunnies to the extent possible, in mutual financial interest of both the parties to the agreement.
- h) Corporation is having RPDS vehicles which shall be utilized for movement of gunnies under this contract wherever necessary and the same cannot be called into question, as it is the first right of the Corporation to use its own vehicles first.
- Successful Tenderer shall produce a letter from the Regional Provident Fund Commissioner of Telangana, sanctioning coverage of the establishment of the contractor under Employees Provident Fund Act, 1952. Even in case, where the number of employees is less than 20, he has to apply for and obtain voluntary coverage of his establishment and produce the coverage letter in evidence before taking up the work under the contract.
- j) Successful tenderer shall submit Income Tax Clearance Certificate for the past three years issued by Income Tax Officer concerned before taking up the work under the contract. PAN No., given by IT Dept. has to be furnished.
- k) As huge quantities of gunnies are to be transported during the contract period within a time bound schedule, the Transport Contractor should have both physical infrastructure in terms of vehicles, maintenance, assured supply of POL, Lubricants etc., to keep up the tempo of transportation as well as financial resources to be able to do so on his own without seeking any mobilization advance from the Corporation for this purpose.
- I) Transport Contractors should have Cell Phone, Computer with Internet connectivity so as to furnish the lifting particulars electronically by phone followed by email / SMS daily. Tracking the vehicle movement in transit from lifting to destination points would need to be done electronically as per instructions of concerned Joint Collector and concerned District Manager or Head office. Necessary standard hardware PC, modem, phone etc. should be at his own cost while special software/hardware if any required as per TGSCSCL specifications shall be provided by Corporation for usage by Transport Contractor.
- m) Incapacity or inability to maintain the required physical and financial resources on his own by the transport contractor would render his tender / contract summarily rejected / cancelled as the case may be on noticing such instances if any.
- n) Transport Contractor should comply with all or any other instructions issued by the Govt. of India and State Govt. from time to time in this regard.
- o) The contents in various Affidavits to be furnished may vary year to year. Hence, the Affidavits to be furnished by the tenderers shall be in the prescribed form only as indicated in the Tender Schedule.

- p) The transport contractor should furnish e-mail address. Any communication sent to e-mail address by the Corporation should be treated as genuine mode of communication and the transport contractor cannot deny the receipt of the communication.
- q) The Contractor may appoint a single person as authorized representative to communicate with Head Office for day to day activities. The same person should not act as authorized representative for more than one contract.

| This Agreement made this Day between the Telangana State Civil Supplies Corporation Limited, Registered under the Companies Act, 1956, having its Registered Office at Civil Supplies Bhavan, H.No.6-3-655/1/A, Somajiguda, Hyderabad, (hereinafter called the Corporation) represented by its VC & Managing Director, TGSCSCL or authorized Officer on one part and (hereinafter called the Transport Contractor) which shall mean and include the person, persons, partners, authorized representatives, firm or Company including legal heirs successors and permitted assignees on the other part witnesses as follows: |
| Whereas the Transport contractor being willing to perform the work of transportation of Gunnies by road from Jute Mills / Godowns located in to various places in the districts of Telangana State on behalf of the Corporation submitted tender in pursuance of the e-Tender Notice No, Date:, and whereas the Corporation has accepted the said tender rates after negotiations vide Procdgs.No, dtd and whereas the transport contractor agreed to perform the duties described under the following terms and conditions. |
| Now this deed witnesses and the parties herein do hereby mutually agree |
| as follows: |
| 1. DESCRIPTION OF WORK: |
| a) The contractor shall transport Gunnies from Jute Mills & Godowns located in to various places in the districts of Telangana State as per the movement orders issued by the Corporation. The volume of work depends on the allotments made by Govt. of India/ Jute Commissioner/Govt. of Telangana from time to time. |
| In case of any deviation in movement of gunnies from the movement instructions issued by the Corporation, transport charges will be paid and restricted strictly as per the movement instructions issued only. The Corporation reserves the right to re-transport stocks wherever transport contractor deviates the movement instructions issued, at the risk and cost of the transport contractor. Action of the District Manager/ Corporation shall not be called into question and no representation in this regard will be entertained. |
| b) The contractor shall transport Gunnies from Jute Mills & godowns located in to various places in the Telangana State as per the movement orders issued by the concerned District Manager/HO, from time to time. In case of any deviation in movement of Gunnies from the movement instructions issued by District Managers/HO, transport charges will be paid and restricted strictly as per movement instructions issued by concerned District Manager/HO. The concerned District Manager/H.O. has the right to retransport stocks as per movement orders, at the risk and cost of the transport contractor. No representation in this regard will be entertained. The decision of the VC & MD in this regard is final and the same cannot be called in to question. |

- c) The Transport contractor shall undertake timely lifting and movement of inspected and passed gunny bales, i.e. stocks should be lifted within 5 days of date of Inspection from Jute Mill premises and deliver to destination Points, failing which penalty shall be imposed.
- d) The transport contractor is prohibited to engage trucks belonging to prohibited or ineligible categories like unfit vehicles, articulated vehicles, vehicles used in other transportation tenders of the Corporation and vehicles used for transportation of fish, poultry and cement, to avoid damages and bad odour. In the event of any lapse on the part of the contractor in this regard, the Corporation shall have absolute right to terminate the agreement at any time during the currency of the agreement and to get the work done for the unexpired period of contract at the risk and cost of the contractor besides forfeiture of the Security Deposit, Bank Guarantee, pending bills, if any, and the contractor will be BLACKLISTED. In this regard, the action of the Corporation is final and binding on the contractors.

2. RATE OF PAYMENT:

a) The above rates include all incidentals, taxes connected with the work entrusted to the contractor under this agreement. In other words, the Corporation shall not be liable to pay to the contractor for any reason whatsoever any remuneration, costs, expenditure on establishment or any other incidentals whatsoever except the due amount at the rates accepted by VC & Managing Director, as shown.

Illustration for payment of transportation cost for transportation of gunnies from Kolkatta is as follows: for example 100 gunny bales from Jute Mill to destination point in the district of telangana involving 400kms then the transportation charges shall be equal to 100 bales * finalized rate in that particular Sector (it's a flat rate irrespective of distance)

b) The contractor is prohibited from claiming any higher rates of transport charges other than those prescribed under this agreement due to escalation in prices of diesel, petrol, etc., for any reasons whatsoever during the contract period or the extended period of the agreement stipulated in it.

3. PERIOD OF AGREEMENT:

a) This agreement will ordinarily be in force from 00.00.2025 to 31.03.2026 or till the quantities of Gunnies entrusted by Corporation to the contractor during the above period is completely transported. The contract can be extended by the VC & MD, Telangana State Civil Supplies Corporation Limited, at his sole discretion on the same rates, terms and conditions for a further period as determined by him for specific reasons to be recorded in writing in public interest of transporting Gunnies. The action of the VC & MD in extending the contract shall be final and binding on the contractor and shall not be called into question.

- b) The Corporation shall have absolute right to terminate the agreement at any time during the currency after giving 10 days notice to the contractor in the normal circumstances without assigning any reason whatsoever and the contractor is not entitled to question the termination on any ground whatsoever.
- c) The contractor or his authorized representative is responsible for the quantity and quality of stocks as taken delivery by him/them for onward transportation to the destinations as per movement instructions issued by the concerned District Manager/H.O from time to time. The Corporation shall have absolute right to suspend the contract at any time during the currency of the agreement without any notice or without assigning any reasons if the contractor or his representative is involved in a case under Essential Commodities Act or any other Acts or violation of any clauses under this agreement. The Corporation shall have absolute right to terminate the contract with immediate effect in case of any diversion or misappropriation of stocks while in his/their custody without assigning any reasons whatsoever. The contractor is also responsible for any acts of his partners, agents, employees, including truck owner, driver/cleaner of the truck in which stocks are loaded for transportation.
- d) The Contractor shall not be entitled to any compensation on account of such termination of agreement.
- e) In case of sudden demise of the Transport contractor the contract cannot be transferred to any of his legal heirs and the new contractor will be appointed by calling fresh tenders for the un-expired period of the contract. However securities can be released to the legal heirs of the deceased on production of Legal heir certificate and No Dues Certificate from the concerned District Managers.

4. SECURITY DEPOSIT:

- a) The contractor shall deposit an amount of Rs. ____ lakhs (Rupees ____lakhs only) towards security for due performance of the service and fulfillment of the terms and conditions of the agreement. The amount of Earnest Money Deposit furnished by the contractor will be adjusted against Security Deposit of Rs. ____ lakhs.
- b) The Corporation will have the right, besides other legal remedies, to forfeit or adjust in full or part, the amount of Security Deposit either for the un-workman like performance of the services by the contractor or for damages, losses, costs, expenses, etc., that the Corporation may suffer or incur due to the negligence or otherwise of the contractor or for violation of any of the terms and conditions of this agreement by the contractor or for violation of any instructions issued by the Corporation from time to time.
- c) Whenever the Security Deposit falls short of the prescribed amount, the contractor shall make good the deficit so that the total amount of Security Deposit does not at any point of time falls short of the prescribed amount.
- d) The Security Deposit or such part thereof as has not been forfeited or adjusted as aforesaid will be refundable to the Transport Contractor only on satisfactory completion of work under the agreement and on submission of "No Demand Certificate" to the concerned District Manager. In turn the concerned District Manager shall issue "No dues Certificate" for refund of the Security Deposit and Bank Guarantee to the Transport contractor on satisfactory completion of the work under the agreement. It is the responsibility of the Transport contractor to get the 'No dues Certificate' issued by the concerned District Manager concerned for release of Security Deposit and Bank Guarantee by Head Office.

e) The Corporation shall not be liable for payment of any interest on the amount of Security Deposit or bank guarantee.

5. BANK GUARANTEE:

The Transport Contractor shall furnish a Bank Guarantee for Rs. ____lakhs (Rupees ____ lakhs only) from a Nationalized/ scheduled commercial Bank in the prescribed proforma in favour of "Telangana State Civil Supplies Corporation Limited, Hyderabad", Hyderabad, within 7 days from the date of entering into agreement failing which the acceptance of the Tender is liable for cancellation and also forfeiture of Security Deposit without any further notice. Only on furnishing of Bank Guarantee, Work Order under the agreement will be issued by the Corporation.

6. OPENING OF A SEPARATE BRANCH OFFICE IN CONCERNED DISTRICTS IN WEST BENGAL AND MAINTAIN REGULAR CONTACT WITH THE CONCERNED DISTRICT MANAGER:

- a) The Transport Contractor shall open a Branch Office in the Town where the jute mills are located and furnish to the H.O. on a non-judicial stamp paper of Rs.100/- the address of the Branch Office, Telephone Number and Name of responsible authorized representative to act on behalf of the Transport Contractor besides the Transport Contractor himself along with their specimen signatures.
- b) The Transport Contractor shall ensure the authorized representative or himself maintains regular touch with the Concerned District Manager/H.O. on day-to-day basis or as frequently as required by the concerned District Manager/HO to obtain delivery orders and movement instructions for the movement of the stocks, information and instructions on work to be done and furnish the concerned District Manager/HO information in writing about work done such as Lorry-wise, destination-wise, godown-wise, Jute Mill-wise movement of stocks on day-to-day basis.
- c) If the Transport Contractor fails to comply with the instructions issued in 6(a) and 6(b) as stated above, the agreement shall be liable for cancellation by giving 10 days Notice.
- d) The transport Contractor shall be responsible to make good the additional expenditure incurred by the Corporation, if any, due to failure to open a Branch Office or to obtain information on daily movement or failure to furnish information about work done on daily basis as per this clause of the agreement.

7. VOLUME OF WORK:

a) The Corporation shall not guarantee any volume of work at any time during the currency of agreement. The mere mention of the item of work in the agreement or the quantities mentioned in the Tender shall not in itself confer any right on the Transport Contractor to demand that the entire work necessarily or exclusively be entrusted to him. The Corporation reserves the right to appoint one or more other Contractors and distribute the work among them during the currency of this agreement at its unfettered discretion in any manner that it may decide and no claim for compensation shall lie against the Corporation by any reasons whatsoever of such division of work. The decision of the Corporation in this matter shall be final and binding on the Transport contractor.

b) The Corporation is having RPDS vehicles and shall be utilized for transport of gunnies under the contract whenever and wherever necessary and the same shall not be called into question.

8. FULFILMENT OF WORK WITHIN STIPULATED TIME AND PENALTY IN CASE OF FAILURE:

- a) The Contractor shall be solely responsible to engage adequate number of transport vehicles for completion of the lifting evenly from the date of the movement order and to complete the entire movement within the stipulated time as per the movement orders issued by the Corporation. The transporter should provide uninterrupted service of transportation of gunnies and at no point of time during the currency of this agreement, interruption/delay in transportation of Gunnies is to be due to non-availability of vehicles.
- b) The Transport Contractor shall transport the allotted and entrusted quantity as per the allotment made within the stipulated time as indicated by the District Manager/ Head Office. Transport Contractor should arrange movement from various Jute Mills and Godowns to Buffer Godowns / MLS Points strictly as per the movement orders issued by the District Manager/ Head Office and ensure that adequate gunnies are positioned at all the Godowns without any disruption of Paddy Procurement Operations. Under no circumstances paddy procurement operations should be hampered or dislocated due to lack of gunnies in any districts. In the event of default on the part of the Transport contractor as aforesaid, the Corporation at its discretion will be at liberty to take up the alternate steps to move the gunnies in order to ensure sufficient gunnies are positioned in paddy procuring districts, in time in public interest, at the risk and cost of the Contractor.
- c) If the contractor fails to lift the stocks in any day as per the movement instructions, the Corporation at its discretion and without terminating the contract will be at liberty to make any alternate arrangements and get the work done at the risk and cost of the Transport contractor who shall be liable to make good to the Corporation all additional charges, expenditure, costs, etc. that the Corporation may incur or suffer thereby. The alternate arrangements means Departmental movement by way of engaging lorries through Lorry Owner's Association or private parties from open market and/or also appointment of ad-hoc contractor (or) through railway rake movement (or) through CONCOR (or) any other available mode at the risk and cost of the contractor for movement of the stocks. The contractor shall however not be entitled to any gain to the Corporation in view of the alternate arrangements. The decision of the VC & MD, TGSCSCL, in this matter is final and binding on the contractor.
- d) The vehicles owned or hired by the transport contractor should possess National permit (All India permit) which is required to undertake movement of gunnies from one state to another state. If the tenderer fails to furnish valid All India transport permit for the vehicles the tender will be rejected without assigning any reasons.
- e) The transport contractor <u>is prohibited to engage trucks</u> belonging to prohibited or ineligible categories like unfit vehicles, articulated vehicles, vehicles used in other transportation tenders of the Corporation and vehicles

used for transportation of fish, poultry and cement, to avoid damages and bad odour.

- f) In the event of default on the part of the contractor in performing his work under the agreement efficiently and to the entire satisfaction of the Corporation, the Corporation shall without prejudice and in addition to other available rights and remedies under the agreement have the right to recover from the contractor by way of penalty of **Rs. 100/- (Rupees Hundred only) per bale, per day** on the unlifted quantity for the delayed period without giving any notice. The decision of the Corporation on the question whether the contractor committed the default and on the quantum of penalty shall be final and binding on the contractor.
- g) In case the contractor fails to lift the entire quantity within the stipulated time.i.e within 5 days of inspection Gunny bales, the penalty will be calculated as follows:

For Example:

Total quantity to be lifted by the contractor 1000 Bales.,
 Quantity lifted by 5th day of inspection 800 Bales.,
 Balance quantity un-lifted. 200 Bales...

Suppose the transport contractor lifts the un-lifted quantities of Gunnies in following order, the penalty will be levied as detailed below:

- h) The imposition of penalties as per the above clause, is the sole discretion of the Corporation because of failure of the contractor to adhere to the movement instructions issued and shall not be called into question and no representation in this regard shall be entertained.
- i) Loss of interest on payments made for the unlifted quantity due to failure of contractor shall also be recoverable from him in addition to penalty above.
- j) Whenever a contractor fails to move the stocks in time to the entire satisfaction of the Corporation, the concerned District Manager/ H.O., is empowered to depute staff to augment the movement in time in this regard. The expenditure towards DA, TA of the staff so deputed, telephone bills, etc., shall be recovered from the contractor.
- k) The contractor shall transport Gunnies from Jute Mills / Godowns located in to the various places in Telangana State as per the movement orders issued by the concerned District Manager/H.O from time to time. In case of any deviation to the movement instructions issued by the concerned District Manager/H.O., transport charges will be paid and restricted strictly as per movement instructions issued by the concerned District Manager/H.O. and the concerned District Manager/H.O. is at liberty to retransport the stocks to other points as per movement orders at the risk and cost of the transport contractor.

I) In case of disruption of roads due to floods, cyclone, collapse of bridge, etc., the Contractor shall obtain prior permission of concerned District Manager/H.O. for transportation via diverted route duly giving reasons specifically.

9. SAFETY OF GOODS:

- a) The contractor shall be responsible for the safety of Gunnies while in his custody and take all possible measures like covering the gunnies after loading with his own tarpaulins, tying with ropes, covering the decks of trucks with tarpaulins to cover crevices or holes. Failing to cover the gunnies and decks of trucks, a penalty of Rs.5,000/- will be levied per each truck, in addition to recovery of damages and losses. The contractor shall be responsible for both the quantity and the quality of the Gunnies, as taken delivery by him, till they are finally delivered at the destinations as per the orders issued by the concerned District Manager. The contractor shall be responsible for all the losses arising in the transportation.
- b) The value of such losses shall be recovered from the contractor at double the economic cost of Gunnies as fixed by the Corporation, whichever is higher, at the time of such loss. Any tampering with the quantity or quality of the Gunnies will involve removal/termination of the contractor and forfeiture of Security Deposit besides prosecution and claim for damages.
- c) As the contractor is responsible for safety of Gunnies while in custody, he/they must take all possible measures like noting of Engine No., Chassis No., Driving License No., and the Photograph of the Driver of the truck engaged by him before the dispatch of the stock from the Jute Mills in order to avoid missing of trucks with stocks, hijacking, etc. In the event of missing of truck, it is the responsibility of the contractor to file the FIR with respective Police Station for investigation and inform the concerned District Manager and the Head Office within 24/48 hours. It is the responsibility of the contractor to make good the loss to the Corporation. This loss shall be recovered from the contractor at double the economic cost of the gunnies lost in the missing truck and the value of stocks will be calculated and recovered as specified in clause 9(b). The contractor shall be liable to pay interest against the value of stocks from the date of missing of the truck till the loss is made good to the Corporation.
- d) In case it is proved that there is no involvement of transport contractor, the VC & Managing Director is empowered to permit the contractor for replenishment of identical stocks to the Corporation at his sole discretion. The contractor shall be liable to pay interest against the cost of the stocks from the date of missing of the truck till the loss is made good to the Corporation.

10. HOLDING OR RETENTION OF STOCKS PROHIBITED:

- a) The contractor is not entitled to retain in his custody the stocks of the Corporation for any reason whatsoever and if he does so, he is liable to pay as per the Clause 9(b) of the agreement for the stocks retained by him in addition to other remedies available to the Corporation. The retention of the stocks by the Contractor is un-lawful.
- b) In case of breakdown of vehicles or for any reason, truck did not reach the destination within reasonable time, the contractor should inform the concerned District Manager or the nearest MLS point incharge immediately. Under no circumstances, trucks should travel beyond the destination point. Any deviation in the said instructions will be treated as diversion of stocks illegally and cost of stocks will be recovered at double the economic cost apart from other penal actions for illegal diversion of stocks as per the terms of this Agreement.
- c) In case of diversion of trucks by Gunny Transport contractor, FIR will be filed against Contractor by name as Accused No. 1. His authorized business

- representative also will be included by name as Accused No. 2.and the lorry driver and cleaner as accused No.3 & 4 respectively.
- d) In case of late hours movement when the destinated Godown may be closed then the Transport Contractor should make arrangements to park the vehicles at some identified Government locations like RDO or MRO Office on that Route so that unauthorized halting of vehicles at Driver's house etc. is avoided.

11. RECOVERY OF DUES:

The Corporation shall have the right to appropriate and set off any sum of money including the Security Deposit and Bank guarantee and any amount payable to the contractor under this agreement or any other agreement with the Corporation against any claim by the Corporation against the contractor under any agreement. Should the above sums be not sufficient to cover the full amount of the claims, the contractor shall pay the Corporation on demand the balance amount due. Otherwise the Corporation is at liberty to recover the amount due under R.R. Act.

12. TERMINATION OF CONTRACT:

- a) The contractor has solemnly stated that he/She/they nor any of their partners/representatives have, at any point of time, been black-listed by the Corporation or by any other Government Agency or involved in diversion of stocks or involved in any case under E.C Act or convicted by Court of Law in a criminal case. In the event of the statement proves to be wrong at any point of time, without prejudice to other rights and remedies, the Corporation is at liberty to terminate the contract forthwith and to get the work done for the un-expired period of the contract at the risk and cost of the contractor and/or forfeit the Security Deposit or any part thereof and also claim from the Bankers who give the bank guarantee for the sum or sums due that may be suffered or incurred by the Corporation due to the termination of the contract in view of the false declaration given by the contractor which comes to light at any point of time. The decision of the VC & MD, TGSCSCL, is final and binding on the Contractor in this regard.
- b) However, if the transport contractor is blacklisted for violation of non execution of agreement, and at a later date revoked by the same organization then an affidavit stating the same shall be furnished as per proforma communicated in ANNEXURE-III).
- c) In the event of the contractor being adjudged insolvent or going into liquidation or winding up his business or making arrangements with their creditors or failing to observe any of the provisions of this contract or is convicted or punished under the provisions of the Essential Commodities Act or State/Central orders issued under the said Act or any other Acts or any of the terms and conditions governing the contract, the VC & MD, Telangana State Civil Supplies Corporation Limited shall be at liberty to terminate the contract forthwith, without prejudice to any other rights or remedies, and to get the work done for the un-expired period of the contract at the risk and cost of the contractor and to claim from the contractor any resultant loss sustained or costs incurred.
- d) It shall be open to the Corporation to suspend the transport contract before ordering termination of the transport contract under this sub-clause. During the period of suspension, the Corporation is at liberty to make alternate arrangements as mentioned in clause 8(c) at the risk and cost of the contractor and the Transport contractor is liable to make good the additional expenditure cost, etc. and the same shall be recovered from the SD/BG/Pending bills available with the Corporation.
- e) The contractor or his representative is responsible for the quantity and quality of the stocks as taken delivery by him for transportation to the destinations as

per the movement instructions issued by the concerned District Manager/H.O within the stipulated time. The Corporation shall have absolute right to suspend the contract at any time during the currency of the agreement, without any notice or without assigning any reasons, if the contractor or his representative is involved in a case under Essential Commodities Act or any other Acts or convicted by Court of Law in a Criminal case. The contractor is responsible for any acts of his representatives, agents, employees, including truck owner, driver/cleaner of the truck in which stocks are loaded for transportation. In other words the Transport Contractor is solely responsible for the acts of his employees or workers engaged by him for transport or otherwise.

- f) Since the transport contractor or his representatives are responsible for the quantity and quality of the gunnies while in his/their/her custody, the contractor shall ensure delivery of gunnies at destination as specified by the concerned District Manager. In the event of failure or diversion of trucks with stocks or even misappropriation of stocks, the VC & MD,TGSCSCL shall have absolute right to terminate the contract without any notice and forfeit the Security Deposit and Bank guarantee and even pending bills besides blacklisting the contractor. The action of VC & MD in this regard is final and cannot be called into question.
- g) The Corporation shall have the right without prejudice to other rights and remedies in the event of breach of the contract or any of the terms and conditions of the contract, to terminate the contract forthwith and to get the work done for the un-expired period of the contract at the risk and cost of the contractors and/or forfeit the Security Deposit or any part thereof and also claim from the Bankers who gives the Bank Guarantee for the sum or sums due for any damages, losses, charges, expenses or costs that may be suffered or incurred by the Corporation due to the contractor's negligence or un-workman like performance of any of the services under the contract. The VC & MD, Telangana State Civil Supplies Corporation Limited, shall also have the right to claim from contractors or to invoke the Security Deposit or Bank Guarantee to recover any dues from the contractor.
- h) In the event of suspension of the Transport contractor due to violation of any clauses in the agreement, all other contracts by the Transport contractor with the Corporation and all other contracts of the said contractor with the Corporation, shall also stands suspended. All payments to the Transport contractor including securities under all Agreements will stand frozen. The decision of the V.C. & Managing Director in this regard is final and cannot be called into question. No correspondence will be entertained in this regard.
- i) In the event of termination of the contractor due to violation of the agreement or under any contract with the Corporation, all other contracts that the Transport contractor has with the Corporation and all other contracts of the said contractor with the Corporation shall also stand terminated. All payments to the Transport contractor including securities under all Agreements will stand forfeited. The decision of the VC & Managing Director in this regard is final and cannot be called into question. No correspondence in this regard will be entertained.

13. LOSS SUSTAINED BY CORPORATION:

The contractor shall indemnify the Corporation for any loss or damage sustained by it due to the improper performance of the work by the contractor under this agreement. Such loss sustained by the Corporation shall be recovered from the bills payable to the contractor and from the Security Deposit and Bank Guarantee furnished by the contractor under this Agreement, or under any other agreements of the contractor with the Corporation. Should the above <u>sums be not</u> sufficient to cover the full amount recoverable, the contractor shall pay to the

Corporation on demand the balance amount due. Otherwise, the Corporation is at liberty to recover the amount due under Revenue Recovery Act.

14. MAINTENANCE AND FURNISHING OF INFORMATION:

- a) The contractor shall furnish to the Corporation daily details of movement of Gunnies as per the movement orders issued, from the source points to destinations lorry wise quantities transported on daily basis without fail in prescribed proforma as communicated by the Corporation.
- b) The contractor shall not only maintain complete accounts but also furnish returns as and when requested by the Corporation in the proforma prescribed by the Corporation.
- c) The contractor shall produce his books and records for inspection and scrutiny by the VC & MD, TGSCSCL, or concerned District Manager or any Officer of the Corporation.
- d) If the contractor fails to furnish the daily progress of movement to the Concerned District Manager, the Concerned District Manager is empowered to obtain the information either over phone or deputing staff and to recover the expenditure like telephone charges and T A., D.A., of the staff from the contractor.

15. SUB-LETTING OF FUNCTIONS:

The contractor shall not sub-let or transfer the whole or part of functions under this agreement or assign any of the benefits under this agreement to any other person, firm or company without the prior approval of the Corporation. Whenever it comes to the notice of the Corporation that the transport contractor who entered into agreement is only a 'Name lender' and doing the work on behalf of other persons, the agreement is liable for cancellation and termination apart from recovery of damages from the Security Deposit, Bank Guarantee and pending bills with the Corporation apart from blacklisting of Transport Contractor and his/her/their authorized representatives. The action of the Corporation in this regard is final and binding on the Transport Contractor and it cannot be called into question.

16. FORGERY OF SIGNATURES:

The Contractor or his/her/their representative should acknowledge the receipt of stocks from Jute Mills / godowns and the same should tally with the specimen signatures furnished to the concerned District Manager by the contractor. If it is found that the signature is forged or signed by some other person as of the contractor / representative, the agreement is liable for cancellation apart from recovery of damages from the Security Deposit and Bank Guarantee and besides blacklisting the contractor.

17. PAYMENT OF BILLS OF CONTRACTOR.

- a) The concerned District Manager will make payment due to the contractor under the Agreement on submission of bills in triplicate supported by proper consignee receipts in original (acknowledgements from the authorized representatives of the Corporation at the receiving ends) along with e-waybills, copy of movement orders etc.
- b) The distances shown in Google Maps shall be taken for payment of Bills. Where, two or more routes are available for the same destination, the shortest route only will be approved for payment of transport charges. The distance will be calculated from the starting source point to the destination point, as per the movement orders issued by the concerned District Manager/ Head Office. In the cases, where approved distances are available with the Corporation, which are shorter than other routes, the same will be consider for payment of transport charges.

- c) Claims should be preferred with proper consignee receipts in full shape along with e-waybills, movement order etc,failing which claim will be rejected. Transport Contractor would be personally held responsible for any delay in settlement of such bills and the Corporation will not make any compensation or interest on such bills.
- d) In case of disruption of roads, collapse of bridges, etc., the contractor shall obtain prior permission of the concerned District Manager for transportation via diverted route i.e., the next available shortest route. The Certificate to that effect has to be obtained by the Transport contractor from Executive Engineer, R & B of the Region concerned. The diverted route shall be followed only from the date of closure till the date of opening of the bridge or route for traffic.
- e) The Corporation will not make any payment of interest on outstanding bills at any time.
- f) Payment will be for no. of bales for gunnies transported from West Bengal. No payment will be made for weight of bags, packing, covers, etc.
- g) Contractor shall claim his bills every month regularly as per issued movement orders only. The bills shall be preferred within 15 days from the date of completion of movement failing which the bills are treated as time barred.
- h) GST, (Income Tax) etc. will be deducted from the payments to the Transport contractors as per rules in force.

18. CLAIMS:

The contractor shall prefer claims, if any, in writing within three months from the date of termination or completion of the Agreement failing which, such claims shall be deemed to have been waived and absolutely barred and the Corporation shall be discharged and released of all liabilities under this agreement in respect of such claims.

19. COMPLIANCE WITH DIRECTIONS:

The contractor shall comply with the directions issued from time-to-time by the VC & Managing Director of the Corporation or the concerned District Manager, regarding the work of the contract under this Agreement.

20. DAMAGE TO THIRD PARTY:

The contractor shall be solely responsible to any third party for any damage or injury caused due to the misfeasance, nonfeasance or malfeasance of the contractor.

21. RESPONSIBILITIES UNDER VARIOUS ACTS:

The contractor shall engage all persons employed by him/her/them as his own servants/employees in all respects and assume responsibility under the Indian Factories Act, the Workman's Compensation Act, 1923. Contract Labour (Regulation and Abolition) Act, 1979, Employees Provident Fund Act, 1952 and other similar enactments in respect of such personnel. The contractor shall indemnify the Corporation against all claims in respect of the aforesaid personnel under the aforesaid Acts and other similar enactments in respect of such personnel.

The contractor shall obtain from the Regional Provident Fund Commissioner, Telangana, sanction for coverage of the establishment of contractor under the Employees Provident Fund Act, 1952. Even in case the number of employees is less than 20, the contractor shall obtain voluntary coverage of his establishment under the aforesaid Act. The transport contractor should furnish necessary clearance certificate from the authorities concerned. In the event of the

Corporation having to pay any amount due to non-observance of the various provisions under the Act, the contractor shall be liable to reimburse the aforesaid amount to the Corporation. The contractor should furnish a declaration under the Employees Provident Fund Act, 1952, about the employees working under him along with other particulars like member-ship liability, payment registers and other documents before commencement of the work under this agreement before the Concerned District Manager concerned without fail.

In the event of any lapse on the part of the contractor in this regard, the Corporation shall have absolute right to terminate the agreement at any time during the currency of the agreement besides forfeiture of Security Deposit, Bank Guarantee.

22. OBSERVANCE OF LAW:

The contractor shall be bound by all laws, orders, etc., in force or issued by the Central or State Government from time-to-time and shall be solely liable for any penal consequences that may incur due to violation by the contractor of any law, orders, etc., in force.

Explanation: Transport contractors are liable to pay Service tax as per the provisions of Service Tax Act or any other law which is in force from time to time and the contractor shall be solely responsible for penal consequences that may arise due to violation of any law, rule or order etc., in force.

23. FILING OF F.I.R. IN CASE OF DIVERSION OF TRUCKS:

In case of diversion of trucks by the contractor without the permission of the concerned Dist. Manager / Asst. Manager/H.O., the Corporation is empowered to file F.I.R. under relevant sections of I.P.C and Cr.P.C against the transport contractor by name as Accused No.1, his authorized district representative also be included by name as Accused No.2, in addition to the lorry driver and cleaner.

24. INFRASTRUCTURE:

As this is a tender for transportation of Gunnies over long distances, therefore, it is needless to specify that one of the explicit pre-requisite is for the tenderers to have both physical infrastructure in terms of vehicles, maintenance, assured supply of POL & lubricants etc to keep up the tempo of transportation as well as financial resources to be able to do so on his own without seeking any obligation advance from the Corporation for this purpose. The tenderers must also have the cell phone, computers with internet connectivity and furnish the lifting particulars by phone followed by E-mail / SMS to the concerned officials of the Corporation. Necessary standard hardware PC, modem phone etc. would have to be provided by the Transport contractor on his/her/their own cost while special software/hardware if any as per TGSCSCL specification would be provided by TGSCSCL for usage by the Transport Contractor.

25. OTHER TERMS AND CONDITIONS:

The terms and conditions set forth in the Agreement together with the terms and conditions set forth in the tender notice and the terms and conditions containing in any other communication exchanged between the contractor and the Corporation shall form part and parcel of this Agreement. The standing instructions of the Corporation in the subject shall also form part of the Agreement.

26. FORCE MAJEURE:

The terms and conditions hereof shall be subject to force majeure. Neither the Corporation nor the supplier shall be considered in default in the performance of their respective obligations herein above if such performance is prevented or delayed because of act of God, War, Flood, Hostilities, Revolution, Civil

Commotion, Epidemic, regulation or ordinance of any Govt. thereof. The supplier shall be entitled to the benefit of this clause only if he informs in writing of the circumstances amounting to force majeure to the Corporation for each consignment/ dispatch separately within 48 hours of the happening thereof by telegram and fax immediately followed by a confirmatory letter sent by Regd. Post Acknowledgment due. In the event of the supplier pleading any ground as constituting force majeure, the opinion of the management of the Corporation on that behalf alone shall prevail and, if in the opinion of the management, the grounds pleaded by the supplier do not amount to force majeure, then supplier shall not be entitled to plead the same and or claim any relief under this clause

26. ARBITRATION:

- a) The Contractor shall prefer a demand, if any, in writing to the VC & MD for arbitration in respect of any claim under this agreement within three months from the date of termination or completion of the agreement, failing which the demand shall be deemed to have been waived absolutely time barred and the Corporation shall be discharged and released of all liabilities under this agreement in respect of such demand.
- b) On receipt of a demand from the contractor within the prescribed time, disputes and differences arising out of or in any way touching or concerning this agreement, except such matters, the decision of which is expressly provided for in the agreement shall be referred to the Arbitration as per Arbitration and Conciliation Act, 1996 and any amendments to the act.
- c) The Arbitration shall deemed to have commenced on the date the arbitrator issued notice to both the parties fixing the date of first hearing.
- d) The Arbitrator(s) may pass their award within two months and from time-to-time with the consent of the parties enlarge the time for making the award.
- e) The venue of arbitration shall be fixed by the Arbitrators in their sole discretion in consultation with the VC & MD.
- f) The Arbitrator(s) shall give separate award in respect of each dispute or difference referred to him.
- g) The costs of arbitration shall be borne by the parties as per the decision of the Arbitrator(s).
- h) The award of the Arbitrator(s) shall be final and binding on the parties to this Agreement, subject to the provisions of Arbitration and Conciliation Act, 1996 and any amendments to the act.
- i) Subject to the aforesaid provisions, the Arbitration and Conciliation Act, 1996 and any amendments to the act shall apply to the Arbitration proceedings under this provision.

27. JURISDICTION:

All civil suits arising under this agreement should be filed in the City Civil Court, Hyderabad only.

28. AFFIDAVITS:

The required affidavits as per the tender Terms and Conditions and this Agreement are listed below and appended herewith.

Eg: (i) Affidavit attested by a notary to the effect that the tenderer has no past or present criminal record with the Police/ Vigilance of Civil Supplies

Department/Vigilance and Enforcement Department, Govt. of Telangana /Govt. of India.

- (ii)An affidavit stating that the tenderer or any of the partners or representatives were never blacklisted by the Civil supplies Corporation/any Government organization at any time
- (iii) An affidavit to be furnished by lorry owners association stating that, none of the Lorry Owners furnished in the list given by the Lorry Owners Association is booked under any Civil Case or Criminal Case or Essential Commodities Act. etc Also that, the vehicle numbers furnished to the Telangana State Civil Supplies Corporation Ltd. to be utilized for movement of gunny bags, belongs to the members of Association and the owners of such vehicles have expressed their consent to utilize their vehicles for the purpose of movement of gunny bags
